A copy of the signed form must also accompany a copy of the AOA Registration Certificate to enter an AOA Show (Halter, Walking Fleece, Fleece, Spin-Off, Cottage Fleece). The Show Superintendent will retain these copies for the show records.
- 3. **NOTE to Buyer and Owner/Seller:** All revoked Owner of Record for Show Entry/Breeder Class Release Forms will be posted at www.AlpacaInfo.com/show on the "Show Forms & Applications" page as "Owner of Record Revocation List" and will contain the date of revocation, alpaca name, registry number, buyer name(s), buyer farm name(s), and owner/seller name(s).
- 4. **NOTE to Show Superintendents:** All Halter, Walking Fleece, Fleece, Spin-Off, and Cottage Fleece Show Superintendents are required to download and print the "Owner of Record Revocation List" prior to each show to ensure compliance with all revocations.
